Product Description

General Description: Pork meat meal is a product obtained from the industrial processing of carcasses, carcass parts, organs, and other residues originating from animals slaughtered in butcher shops and slaughterhouses. It must not contain blood, hair, bristles, feces, hooves, stomach contents, specified risk materials (SRM), or residues from animals slaughtered in unauthorized facilities.


